#### NOTICE OF ANNUAL MEETING, BUDGET VOTE, AND ELECTION GENERAL BROWN CENTRAL SCHOOL DISTRICT COUNTY OF JEFFERSON, NEW YORK

Revised as per Governor Andrew Cuomo's Executive Order No. 202.26:

NOTICE IS HEREBY GIVEN, that a public hearing of the qualified voters of the General Brown Central School District, Jefferson County, New York will be held remotely in said District on June 1, 2020 at 5:30 p.m. prevailing time, for the presentation of the budget.

NOTICE IS HEREBY GIVEN, that the annual meeting of the qualified voters of the General Brown Central School District, Jefferson County, New York will be held via absentee ballot in said District on Tuesday, June 9, 2020 upon the following items:

- 1. To adopt the annual budget of the School District for the fiscal year 2020-2021 and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.
- 2. To elect two (2) members of the Board of Education for 3-year terms commencing July 1, 2020 and expiring on June 30, 2023 to succeed two members whose terms expire on June 30, 2020.
- 3. To approve the following proposition:

<u>Proposition #2</u>: In the event Proposition 1 The Annual Budget, is NOT approved, "Shall the Board of Education be authorized to purchase up to four (4) school buses of varying capacities at a cost of not to exceed \$375,000 or so much thereof as may be necessary, to be financed by the funds accumulated in the Bus Purchase (Capital) Reserve Fund"?

AND FURTHER NOTICE IS HEREBY GIVEN that a copy of the statement of the amount of money which will be required to fund the School District's budget for 2020-2021 exclusive of public monies, may be obtained by any resident of the District upon request or by accessing the District website at www.gblions.org.

AND FURTHER NOTICE IS HEREBY GIVEN that candidates for the office of member of the Board of Education shall file written notice with the Clerk of the School District in the District Office not later than 5:00 p.m. EST, May 11, 2020.

AND FURTHER NOTICE IS HEREBY GIVEN that applications for absentee ballots may be requested by contacting the District Clerk at dbennett@gblions.org. Absentee ballots must be received by the District Clerk not later than 5:00 p.m., prevailing time, on June 9, 2020.

AND FURTHER NOTICE IS HEREBY GIVEN, that the qualified voters of the School District shall be entitled to vote at said annual vote and election. A qualified voter is one who is (1) a citizen of the United States of America, (2) eighteen years of age and older, and (3) a resident within the School District for a period of thirty (30) days next preceding the annual vote and election.

The School District will also require all persons offering to vote via absentee ballot to provide their signature, printed name and address.

AND FURTHER NOTICE IS HEREBY GIVEN, that pursuant to a rule adopted by the Board of Education, in accordance with §2035 and §2008 of the Education Law, any referenda or propositions to amend the budget, otherwise to be submitted for voting at said election, must be filed with the Clerk of the School District in the District Office on or before May 11, 2020 at 5:00 p.m. prevailing time; must be typed or printed in English, must be directed to the Clerk of the School District. However, the School Board will not entertain any petition to place before the voters any proposition the purpose of which is not within the powers of the voters to determine, or any proposition which fails to include a specific appropriation where the expenditure of monies is required by the proposition.




# Distribution of 2018-2019 Graduates

### Highlights from 2019-2020

- Reconfiguration of Dexter and Brownville-Glen Park into a PK-2 and 3-6 building was successfully completed.

# The Budget Process



### **Budget Process**

- The Board of Education begins formal budget discussion in January following the Executive budget proposal
- Once the State budget is adopted, the Board of Education adopts a spending plan that balances the needs of the students and that of the taxpayers

#### Revenue Factors

 Foundation Aid remains flat; No increase from current year.

Building Aid was increased by \$389,546

Tax Levy Increase yields \$424,614

## **Budget Factors**

 Salaries and benefits increased by \$449,028

BOCES costs decreased by \$1,447,377

 Contractual and insurance costs increased by \$158,625

# Proposed Spending Plan 2019-2020



## The Proposed Spending Plan

#### Proposed Budget of \$24,334,794

- Tax levy increase of 05.4% (\$424,614)
  - Property Tax Cap Compliant
- Maintains current staffing and programs



### **Proposed Tax Levy Increase**

2019-2020 Tax Levy: \$7,856,032

2020-2021 Tax Levy Increase	\$ Increase	Total Tax Levy
5.4%	\$424,614	\$8,280,646

Adoption of this budget must be approved by a simple majority (50% + 1) because the tax levy is within the tax cap of 5.4%

## 3 Component Budget

 Format, as recommended by the state, shows total budgets for each functional area of the school.

 Each functional area is assigned a code; for example, code 1210 represents the total budget for the Superintendent of Schools Office (salaries for the Superintendent and her Secretary, and budget amounts for contractual expenditures and supplies for the Central Office).

## **Contingency Budget**

If the proposed budget is NOT approved by the required margin, the Board may:

- Resubmit the original budget
- Submit a revised budget to the voters on the third Tuesday in June
- Adopt a contingency budget that levies a tax no greater than that of the prior year (0% increase in tax levy).
