4. Board Action – **SEQRA RESOLUTION – Building Renovations (CRRSA Funded Project)**

WHEREAS, the Board of Education of the General Brown Central School District (“Board”) is considering to undertake a project involving renovations to its existing Brownville-Glen Park Elementary, Dexter Elementary, and High School buildings, the project includes upgrades to existing mechanical (including heating system piping, boiler replacements, ventilation system improvement and mechanical systems controls (“the Project”), and

WHEREAS, the Board wishes to fully comply with its obligations under the State Environmental Quality Review Act (“SEQRA”) and the regulations thereunder with respect to the proposed action; and

WHEREAS, the Board has carefully considered the nature and scope of the proposed action; and

WHEREAS, upon review of the foregoing, the Board makes the following determinations:

1. The proposed action involves the removal and replacement of deteriorating ventilation system actuators and other upgrades to existing mechanical, and mechanical control systems in the Brownville-Glen Park Elementary.
2. The proposed action involves upgrades to existing mechanical systems, and mechanical control systems in the Dexter Elementary.
3. The proposed action involves the removal and replacement of deteriorating ventilation system actuators, replacement of existing boilers, roof top units and other existing mechanical systems, and mechanical control systems in the High School.
4. The proposed project represents maintenance or repair involving no substantial changes in an existing facility or structure within the meaning of 6 NYCRR 617.5(c)(1); and/or alternatively the replacement, rehabilitation or reconstruction of a structure or facility in kind within the meaning of 6 NYCRR 617.5(c)(2); and/or alternatively a routine activity of an educational institution, including expansion of existing facilities by less than 10,000 square feet of gross floor area, within the meaning of 6 NYCRR § 617.5(c)(8).
5. The proposed action will in no case have a significant adverse impact based on the environment based on the criteria contained in 6 NYCRR § 617.7(c), and is not otherwise a Type I action as defined by 6 NYCRR § 617.4.
6. The proposed action is Type II action within the meaning of 6 NYCRR 617.5 and is therefore not subject to review under SEQRA and the regulations thereunder.
7. The District is hereby authorized to undertake the necessary work described above utilizing the CRRSA funding and to expend an amount not to exceed \$1,243,597.
8. The Superintendent of Schools and all officers and authorized employees of the District are hereby authorized and directed to take all steps reasonably necessary or appropriate to complete the Project and to carry out the intent of this Resolution.

NOW THEREFORE BE IT RESOLVED, that the General Brown Central School District Board of Education finds and concludes that the proposed action is a Type II action within the meaning of 6 NYCRR 617.5 and therefore is not subject to review under SEQRA and the regulations thereunder.
